Statement of Consent

1. Disqualification of Anti-Social Forces

- If the applicant (either the individual or any member of the group) has been determined to be acting in support of the activities of an anti-social force, their entry will be disqualified.
- Even if this determination has been made after the selection process, the selection will be revoked without warning. The committee is not liable to pay any damages whatsoever that may occur in this case.

2. Copyrights and Other Rights Regarding Work Submitted

- Materials submitted for work that is selected (including the entry form, planning documents, photographs, and materials from past work) will be used without charge for advertising purposes (such as in pamphlets and on the website). These materials may also be edited for use, including image cropping.
- The organizer reserves the right to save or dispose of data, documents, and other assets that are submitted. These will not be returned.
- Any submitted work that runs counter to existing laws and ordinances, contracts, or public policy doctrine will not be accepted.
- The copyright on work submitted belongs to the entrant. However, the announcement, public release, and usage rights (including publicity and advertising) belong to the organizer. Specific examples of the above include display of work and usage of photographs and videos taken by the organizer of said work on the official website, various pamphlets and collections for record-keeping (including video materials), and other uses.
- Ownership of works created with expenses provided by the Roppongi Art Night Executive Committee belongs to the organizer.
- The entrant guarantees that the work submitted does not infringe upon the rights of any third party. If a complaint is received from a third party, we ask that the entrant take the responsibility of resolving it on their own. Most music in Japan is administered by JASRAC (Japanese Society for Rights of Authors, Composers and Publishers). Entrants are asked to consult with JASRAC regarding any songs selected for use.
- Please ensure that the work adheres to the community guidelines of YouTube's video hosting service.
- The entrant asserts that their work has not been published or exhibited previously. If any discrepancies or false information are found on the entry form or materials submitted, or if the entrant has not complied with the rules, or in case other issues are found, their acceptance will be revoked.
- The organizer will not be held responsible for any accidents, injuries, or other damages that may occur during the exhibition.
- Applicants are required to take out insurance against theft or damage of their works.

3. Roppongi Art Night Executive Committee will determine the open period of the event.

- The entrant agrees not to publish the work on any other website for the duration of Roppongi Art Night 2023.
